Note that Government Offices are closed on every public holiday, Saturday and Sunday throughout the year, but are otherwise open for business each week from Monday through Friday, 8:45 a.m. to 5:00 p.m. Public holidays that fall on a Sunday are normally observed the following day.

NOTE FOR THE YEAR 2011

As New Year's Day, 1st January 2011, falls on a Saturday, Government Offices will be closed on Monday, 3rd January.

As Christmas Day, 25th December 2011, falls on a Sunday, by virtue of the Public Holidays Act 1947, Tuesday, 27th December will be kept as a public holiday according to the Schedule to the Act.

NOTE FOR THE YEAR 2012

As New Year's Day, 1st January 2012, falls on a Sunday, by virtue of the Public Holidays Act 1947, Monday, 2nd January will be kept as a public holiday according to the Schedule to the Act.

As Remembrance Day, 11th November 2012, falls on a Sunday, by virtue of the Public Holidays Act 1947, Monday, 12th November will be kept as a public holiday according to the Schedule to the Act.
